**GROW** is a family volunteer- run tax exempt INDEPENDENT organization advocating on behalf of persons with all types of intellectual and developmental disabilities, (IDD), in NYS.

Throughout **GROW**'s 40 year history, **GROW** has proven to be an important and effective advocacy organization.

Throughout its history, **GROW** has maintained a close relationship with agencies and legislators. We make yearly trips to Albany to meet with OPWDD and our legislators as well as meeting locally with them.

We also hold monthly meetings on topics of concern.

These activities have enabled to achieve so many services and rights for your child/family member.

Strength in numbers will help retain the gains of the past and promote a high level of achievement in the future.

#### **HIGHLIGHTS OF GROW'S HISTORY**

Founded in 1981 by parents of individuals already in group homes, GROW members decided to advocate for all individuals with intellectual and developmental disabilities.

Notable accomplishments of **GROW** are the following:

**GROW** originated the Registry of Persons with Developmental Disabilities in Westchester County, the first registry in the entire state. It was many years later that OPWDD created a registry.

**GROW** instrumental in production of many useful pamphlets including:

- Directory of Physicians and Dentists who treat individuals with developmental disabilities.
- Information packet for parents for Committees on Special Education
- Difference between certified and uncertified residential opportunities
- Transition Planning Guide
- Rights of Guardians (OPWDD)

In 1998: **GROW** spearheaded a class action suit against NYS to address long waiting lists for residential services. This resulted in the creation of NYS CARES which resulted in thousands of persons receiving appropriate residential services

**GROW** advocacy for health and safety:

- provided key support in preserving The Westchester Institute for Human Development.
- helped ensure passage of legislation for criminal background checks with fingerprinting of new direct care employees.
- spearheaded laws ensuring fire safety
- developed the first Ombudsman program for people with Intellectual and developmental disabilities
- advocated and continues to advocate for COLA and increased pay for all direct care workers.
- advocated and continues to advocate for INCREASES not DECREASES in funding for programs
  - respite
  - recreation
  - early intervention
  - job couching and job training
  - State education programs

**GROW** has worked and continues to work s for meaningful dialogue and input with caregiver and governmental agencies through;

- Establishment of working relationships with advocacy groups throughout the State.
- Creation of the Guardian Rights pamphlet (OPWDD)
- Participation on the panel for Managed Care.
- Ongoing meetings with legislators, and governmental agencies
- Actions towards preserving rights on The Committee of Special Education
- Participation on Westchester County Community Services Board
- Participation on Westchester County Dept of Community Mental Health Committee
